Eligibility:

- (A) Candidate must have a M. Sc./ B. Tech. in Biotechnology/ Bioinformatics/ equivalent life sciences or M.B.B.S.
- (B) Preference will be given to the candidate having: -
 - (1) Qualified ICMR-JRF/CSIR- JRF/NET.
 - (2) Experience in next-gen sequencing and data analysis.

Upper age limit: Not more than 28 years.

Emoluments: Consolidated pay of Rs. 31,000/- + 16% HRA (4960/-) / per month

Tenure of Project: 03 Years

The Terms & Conditions for the posts are as follows:

- 1. The post is to be filled up only on **purely temporary basis** and will be renewed annually.
- 2. The project started on 26/09/2019. The duration of the project is for three years.
