Application fees (for candidates belonging to unreserved category Rs 500/- and for candidates belonging to reserved categories Rs. 200/-) for online application can be deposited through bank challan or fund transfer in to SBI Account No - 33599761355, IFSC Code - SBIN0000461, Branch - State Bank of India, Main Branch, Raipur (CG) of the Institute. The format for the bank challan is available on the website. Online application form will be available to the applicant only on filling the bank challan number or providing the details of depositing the application fee through fund transfer.

#### Terms and conditions:-

- 1. Separate application has to be filled for each applied position.
- 2. It is mandatory that the candidate should hold the essential qualification and experience etc., on the date of advertisement. Any eligibility related certificates issued after the date of advertisement will not be accepted.
- 3. Incomplete and ambiguous applications shall be summarily rejected.
- 4. The rights of appointing authority will be reserved for any change, cancellation, increase or decrease in the number of all or some positions.
- 5. Dearness allowance and other allowances will be payable as per orders of government of state time to time in addition to scale of pay given with advertized positions.
- 6. Applicants working in Chhattisgarh Government or its various ventures/ organizations and Government of India or its private ventures or private organizations and any university, shall have to produce a No Objection Certificate from the appointing authority or office bearer at the time of verification.
- 7. As the advertized medical positions are full time, so registration at M.C.I. / Chhattisgarh Medical Council is mandatory.
- 8. Candidates belonging to Scheduled Castes (SC), Scheduled Tribes (ST) and Other Backward Classes (OBC) must possess a permanent caste certificate issued by competent authority, which is mandatory to be produced at the time of verification.
- 9. It will be mandatory to produce certificate of class 5<sup>th</sup>/ High School/ Higher Secondary, as a proof of age of candidate, at the time of verification.

- 10. Minimum age limit for all the advertized positions is 18 years as on 01.01.2014 and maximum age limits are mentioned along with respective positions, calculations regarding relaxation in this will be done as per orders regarding maximum age limit, issued by Chhattisgarh Government time to time.
